

Military Student Identifier Position Statement

Background

The Military Child Education Coalition (MCEC) is a 501(c)(3) global non-profit organization that provides evidence-informed programs, professional development, best practices, and resources customized to serve the needs of military-connected children¹. For over twenty-five years, MCEC has supported the identification and inclusion of all military-connected students by educating, advocating, and collaborating to resolve education challenges associated with the military lifestyle. The Military Student Identifier (MSI) was mandated in the Every Student Succeeds Act² (ESSA of 2015) to require that states and districts report on the performance on state assessments of students with a parent in the military. MSI is a critical tool for educators and policymakers to offer resources and direct strategies to support all military-connected students (K-12). MSI can also ensure academic, social, emotional, behavioral, and mental health needs are recognized, supported and that appropriate responses are provided to all military-connected students. This student population includes the over 2.3 million youth caregivers who live with a wounded, ill or injured service member or veteran.³ A recent study by RAND found that about 40% of military and veteran connected children under 18 living in caregiver households help with caregiving tasks.⁴ The additional social, behavioral, and mental health challenges as well as extra responsibilities at home can be overwhelming and take the forefront to school success and the youth's own mental well-being.^{3, 4}


Executive Summary

While the National Defense Authorization Act (NDAA) of FY 2020, Sec. 579⁵ Annual Report Card removed the "on active duty" requirement for the ESSA of 2015 in an effort to expand the definition of military-connected students, the Code of Federal Regulations, Title 34 §200.2(b)(1)(ii)(D) and §200.2(b)(11)(i)(l)6 continues to include only students with a parent who is a member of the armed forces on active duty and serves on full-time National Guard duty. This conflicting information leads to ambiguity about who is included. Consequently, there are inconsistencies in data-reporting systems, and schools may inadvertently exclude students of reserve component members, veterans, youth caregivers, or Gold Star children.

Federal MSI Requirements

The Every Student Succeeds Act codified the recognition of military-connected students as a distinct subgroup for reporting purposes mandating the use of MSI. According to the Military Child Education Coalition7 ...


Schools regularly disaggregate student demographic and performance data to determine program effectiveness to identify areas requiring attention or resources and to detect students in need of specific academic assistance. MSI data provide an additional dimension that more finely attunes the schools' programs to respond to the needs of children. MSI is essential to improve and personalize social emotional academic development (S.E.A.D.) for the highly mobile military-connected student.

Recommendations

In accordance with the September 3, 2024 U.S. Department of Education guidance, at a minimum use a military-connected student definition in data reporting systems that include students with a parent on active duty, full-time or part-time National Guard or Reserve duty in the armed forces (Air Force, Army, Navy, Marine Corps, Space Force, Coast Guard).8 Additionally, MCEC strongly recommends identifying students (K-12) with a parent who is a military retiree (including retired Reserves) or veteran (including service members who died on active duty) to ensure support of Gold Star children and youth caregivers.
